President Report

TRACKING CLUB OF VICTORIA INC.

ANNUAL GENERAL MEETING 2012

Hello Everyone,

What a fun but tiring year 2012 was.

The year kicked off for events in April with the Test 1 trial held at Officer, followed a week later with the annual training workshop weekend at Shepparton, where there were many budding stars of tracking uncovered. It never ceases to amaze me how well the dogs pick up the concept and how ecstatic the handlers are on how much their dogs improve over the weekend. It is very rewarding for the instructors as well, who love nothing else than to see the teams progressing and enjoying themselves.

As we all know there are so many members who assist in the running of this weekend for the Club including all the instructors, catering crews etc. Thank you to everyone involved for without your assistance the weekend would not happen.

In regard to the Shepparton site, some of you may be aware that it has been vandalised on several occasions since we were there earlier this year and they are unable to advise us whether it will be habitable for next year's weekend so the Committee has decided to relocate the workshop to Officer and run it immediately following our Test 1 trial.

Then just a week later the Club held its TSD test 1-5 trial at Haddon. This was a lot of fun with lots of passes and some really lovely new areas located in and around the township of Haddon for our tracks. As you can see from just the month of April the TCV Committee and members hit the ground running once the season commences. The Club then went on to run a training day at Brimbank Park and a General Meeting at KCC Park during May.

In June we held a TSD 6 Trial in the Canbourne area and a TSD Test 1-5 at Inverleigh.

July was the month of our tracking trial at Broadford which is always well attended. The Champion of Champions event was also held in July and just before we were all to head off up the Hume Highway to Shepparton we were advised that due to

the Committee managed to secure the Inverleigh Common and the hall at Murgheblac so the event could proceed. A lovely time was had by all who attended and we intend to run the event there again in 2013.

August saw the running of the open tracking trial at Inverleigh which as always was a great weekend with loads of laughs.

We finished off the season with our TSD Test 6 trial in September.

My sincere thanks to all the judges, stewards, gophers, tracklayers, caterers, competitors and members who assisted in any way in the running of all of these events during 2012.

Whilst all these events were going on in 2012 there was also an ANKC Rule Book review for both Tracking and Track and Search which some of our members made submission to and attended the meeting to voice their thoughts on what rule changes would benefit our sport.

The Victorian submission has now been collated with all the other state submissions and a meeting for both judges and handlers has been organised to discuss the submissions for Tracking and TSD at KCC Park on Monday 4th February 2013, notification will be in the December VicDog.

I am pleased to advise you all that the TCV currently has 227 members, and those members have been very active in tracking in the past season with 177 title medallions being awarded tonight. (This is 7 more than last year!!) This includes 29 new Tracking Champions and 25 TSDX title. What a wonderful achievement, one, which you should all be very proud of!!

On the subject of title medallions the Committee has been very accommodating in awarding medallions for previous years when a member has missed applying for them; however this is becoming a bit of a landslide with some members applying for multiple years at one time. As you can see from the number of titles being awarded this is a huge job, involving collating and checking all the details and this job is done by our ever efficient Secretary Sue Keane. So the Committee has taken the decision to cease this practice in the future. However should there be an exceptional circumstance which made it impossible for you to apply for your title by the closing date, a written application to the Committee should be made for consideration. Medallions will only be awarded for the season immediately preceding the current one in any of these cases.

It is with regret that I have to inform you that Deb Hamilton has decided to resign as our Newsletter Editor and therefore the Committee would like to hear from any member who might like to take on this task. The club newsletter is a very important tool which keeps our members informed and up to date, Deb has done an outstanding job as editor for several

years and she will be sadly missed, we thank her sincerely for all the time and effort she puts into every edition.

I am happy to advise you all that the Committee has commissioned a new website for the TCV which is currently under construction, the draft design has been approved by the Committee so work is now underway populating it with all the relevant information you as members require. The Committee has also decided to pay the designer company a nominal fee to become the webmaster of the site which will enable us to email directly items, which, will be updated on the website within a few days following each trial, meeting etc.

The site will be operational by January 2013; you will receive an email once the news site is launched.

Tonight we will be awarding several members with service awards for their outstanding contribution to the TCV during 2012, we will also be celebrating the awarding of life memberships to two very well-known and respected members of the Club and I speak of Tony den Hartog and Jill Spencer who have both been an integral part of the TCV over many years, the Committee and Members congratulate you all!!

It is an honour and privilege to be the President of this Club and to work with this Committee of outstanding individuals; they all work tirelessly to ensure everything runs like clockwork.

This year sees all the current committee members re-nominating for the 2013 Committee, which is outstanding.

My sincere thanks to Gary Fainges, Vice President, Sue Keane, Secretary, Julie Short, Treasurer, Roger Corlass, Membership Officer, Dawn Howard, TSD Trial Secretary, Andrea Sciberras, Tracking Trial Secretary and Jill Spencer, Raffle and Fundraising Co-ordinator for all your hard work enthusiasm and support during 2012.

I would like us all to take a moment to reflect on all the wonderful dogs that left us and made their way to Rainbow Bridge during 2012, to be remembered always.....

In closing, my personal thanks to the entire membership for your assistance and support over the last twelve months and I look forward to another enjoyable and fun year in 2013.

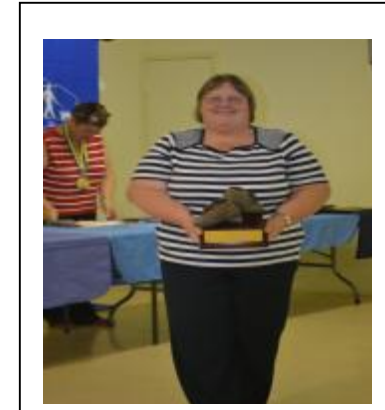

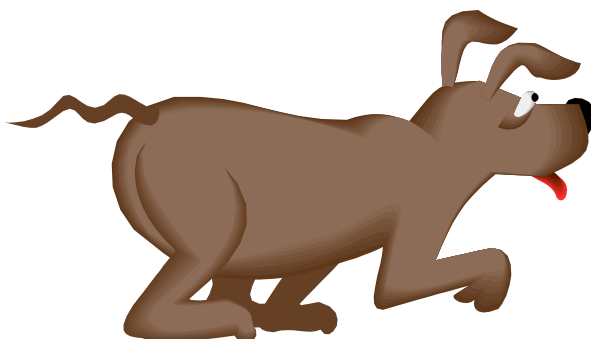

How to Email a Picture

Most pictures will be located in the folder "My Pictures"

1. Compose a message in your email software, such as Outlook.
2. Find the button for attachments on your email software. It may look like a paper clip and it will probably say "attach files".
3. Click on that button. An explorer window will open.
4. Navigate to the folder where the file you want to send is located. For example, My Pictures/2012Jan/0123.jpg
5. Click on the name of the picture.
6. If you want to send more than one file, hold down the "control" key and click on the additional file names.
7. The display of the email message you're sending will have changed. It will now say something like "attachments (1) 0123.jpg"
8. The message will probably also tell you the size of the file(s) you have attached - "140KB" for example.
9. Press "send"

Email with attachments takes longer to upload than plain text. If your photos are large, it may take a minute or more.

How to Rename a File

One way to rename a [file](#) is to open the [program](#) that was used to create the file, open the file, and then save it with a different name. However, there's a quicker way:

1. Right-click the file that you want to rename, and then click Rename.
2. Type the new name, and then press Enter.
